

## **HME Free Trial Terms and Conditions**

By participating in the Free Trial (defined below), you agree to abide by [Terms of Use](#) and [Privacy Policy](#) of HM Electronics, Inc. (“**HME**”) and these terms and conditions for the applicable free trial of HME’s product(s).

### *HME 30-Day Free Trial*

HME offers a trial free of charge of certain of its products and services (the “**Free Trial**”). For the Free Trial, you will be permitted to access and use an eligible HME product or service selected by you for thirty (30) calendar days following your enrollment in the program (the “**Free Trial Period**”). Eligible products and services will be selected for the Free Trial by HME in its sole discretion.

At the end of the Free Trial Period, your access will be terminated and all data you input into or stored on the product or service will be deleted. You should download any data you wish to retain before the end of the Free Trial Period.

You are not required to purchase any product or service in order to participate in the Free Trial. At the conclusion of your Free Trial Period, you may, but are not required to, contact HME to purchase the product or service on a paid basis.

To enroll in the Free Trial, you are required to provide your full name, email address, phone number, business affiliation, store number and mailing address. You agree that HME may, directly or indirectly through the services of third parties, collect and store the information related to you and your use of HME’s product(s) as part of the Free Trial. You also agree that HME may use that information to send to you via electronic or physical mail promotions and updates regarding its products and services. All information HME collects through this Free Trial is subject to the [Privacy Policy](#) of HME.

You may only use one Free Trial. If you attempt to enroll in more than one Free Trial, HME may reject your request.

The Free Trial version of the HME product or service generally has fewer features than the paid version of the product or service. The additional features cannot be added to the Free Trial or purchased as a part of the Free Trial.

Please note that technical support is not available during the Free Trial. The Free Trial is provided as a convenience and you agree that HME is not obligated to provide any technical support, phone support or updates for any of HME’s product(s) accessed or used within the Free Trial environment.
